2. Update on the contracts

- a. Ours is with the UWHC fiscal agent
- b. There are issues with the contract, but not worth fighting at this point, so late in the contract
- c. We will focus on the non political issues in this session

3. Registry issues (Sauk Prairie), no password, etc, so no trauma data has been entered for an extended period of time. Sauk Prairie is scheduled with the DRC to have a site review; however nobody at Sauk Prairie has reportedly received any info from the state about the visit. Lynne is working to resolve this issue. The visit will not be rescheduled.

4. Certificates from the State reference to verification status: some hospitals have not yet received these certificates. Check your hospitals status, and get in contact with Lynne Sears (lsears@uwhealth.org) if your agency has had a site review, but has not yet received a certificate.

5. Trauma System Work-shop: Members present recommended repeating the one-day workshop that will help our RTAC's hospitals prepare for site reviews, in addition to assisting our hospitals' new members/staff that are filling vacant trauma system roles.

7. EMS run reports: the Level 1 is being 'dinged' for not having EMS run reports associated with each trauma patient. Most of these missing documents are from EMS agencies that transfer to Level III and IV facilities prior to transferring to the Level 1. The Level 1 cannot go back into the system to get these documents. So, we are proposing that all Level I and II trauma centers be given global access to all hospitals in the RTAC to obtain these documents.
8. In-service for med-surge nurses: This was proposed and supported at our last Trauma Coordinators meeting. "Care and Transport of the Traumatically Injured" is a new book/edition out that is very inclusive of the items that should be covered in this proposed program. Goal is September/October 2009
